Doggie Day Care Owner Agreement and Waiver

I (the owner) understand that I am responsible for any harm caused by or incurred by my dog while my dog is attending doggie day care at Grafton Animal Hospital, Inc. I will not hold Grafton Animal Hospital, Inc. or any of its staff liable for any losses or damages of any kind as a result of my failure to inform Grafton Animal Hospital, Inc. of any pre-existing condition that my dog may have (such as illness or aggression problems.) I understand and agree that allowing my dog to attend doggie day care, the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.

Grafton Animal Hospital, Inc. (also known as GAH and 'the facility') agrees to exercise due diligence and reasonable care and to keep the premises sanitary and properly enclosed. All pets are handled and cared for by GAH staff without liability for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other pets, or property by said pet(s), or from other unavoidable causes, due diligence and care having been exercised. Owner gives consent that pet(s) can be housed in enclosures with pets of different ownership.

I understand and agree that GAH will not be liable for problems, damage, or injury caused by or incurred by my dog provided day care staff follows reasonable care and precautions. I understand that Grafton Animal Hospital, Inc. is fully insured. I release Grafton Animal Hospital, Inc. of any liability arising from my dog's attendance and participation at the daycare. I understand that the daycare is a place where animals co-mingle in groups. I recognize that there are inherent risks of illness or injury when dealing with pets playing in a group environment. Such risks include, but are not limited to, problems resulting from rough play, food scrap found outdoors and contagious diseases such as coughs and diarrheas (doggie colds). Some of the common problems include but are not limited to becoming dirty and muddy, bruises, cuts, nicks, scratches, scrapes, broken nails, and bite wounds. Daycare staff may or may not notify me immediately. If the injury is not serious staff may feel it is ok to wait until the end of the day and let me know about it when I pick up. If the injury is serious, I will be notified immediately.

I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by Grafton Animal Hospital, Inc. and staff in their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

I, as the owner, agree to be solely responsible for any and all acts or behavior of my pet while in the care of Grafton Animal Hospital. Pets must be in good health and not carrying any contagious disease that can be transmitted to other pets. If my pet should become ill or seem to be in need of medical consideration, Grafton Animal Hospital, reserves the right to administer aid and/or to use any available veterinarian and veterinary facility. I, the owner, shall pay any expenses incurred.

I understand that if my dog is left at the day care for a period of three days without contact from the owner, this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities or otherwise handled as the law allows.

The pet(s) must be current on the following health care by GAH standards: DHPP within one year (3 years in select cases as defined by GAH), Rabies within one or three years as defined by law, Bordetella within 6 months, a fecal exam within the past year (negative result or followed
